6. Monitoring and Evaluation

- Performance Metrics: Establishing clear performance metrics and indicators to evaluate the success of the integrative approaches in education and healthcare.
- Regular Assessments: Conducting regular assessments and reviews to ensure that the institution's practices align with its goals and vision, making adjustments as necessary based on the findings.

By adopting these recommendations, Madinat al-Hikmah can continue to refine and enhance its integrative models, ensuring they remain effective and relevant in addressing contemporary educational and healthcare needs while preserving traditional values.
